

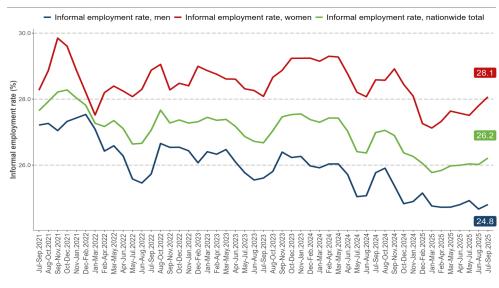
### STATISTICAL BULLETIN: LABOUR INFORMALITY<sup>1</sup>

No. 32 / 4 November 2025

Note: This document is a translation of the official Spanish version of the Labour Informality bulletin.

- In the July-September 2025 quarter, the informally employed population decreased 1.4%, which is equivalent to a fall of 36,167 persons.
- In the same period, the informal employment rate was estimated at 26.2%, a twelve-month decrease of 0.8 percentage points (pp).
- By economic sector, the decrease was mainly due to the falls in commerce (-5.1%) and manufacturing (-4.8%).
- By occupational category, the decrease in informally employed persons was influenced by the falls in own-account workers (-5.1%) and wage earners of the public sector (-8.1%).

### Informal employment rate

In the July-September 2025 quarter, the informal employment rate de- The main influences on the decrease in the number of informally emcreased 0.8 pp year on year to stand at 26.2% as a result of the fall in the informally employed (-1.4%) and the overall growth in the employed pop- 54 years (-5.5%). ulation (1.5%).

According to sex, the decrease in the informally employed was due to the falls in men (-2.3%) and women (-0.4%). In the same period, the informal employment rate for women decreased 0.5 pp to stand at 28.1% and the rate for men decreased 1.0 pp to stand at 24.8%.

### Analysis by age bracket

According to sex, the main influence on the decrease in informally employed men and women was the bracket 25-34 years, which fell 10.0% and 4.6%, respectively.

The highest informal employment rates of the quarter were in the brackets 65 years and over (57.6%) and 15-24 years (37.4%). These results reveal that informal employment is most prevalent in the highest and lowest age brackets, affecting the old and the young.

### Main indicators

### Economic activity<sup>2</sup>

The year-on-year decrease in the informally employed population (-1.4%) was influenced by the falls in commerce (-5.1%) and manufacturing (-4.8%).

In the same period, the decrease in informally employed men (-2.3%) can mainly be attributed to the falls in commerce (-5.5%) and transport and storage (-7.1%). In contrast, the decrease in informally employed women (-0.4%) can mainly be attributed to the falls in commerce (-4.8%) and agriculture and fishing (-19.7%).

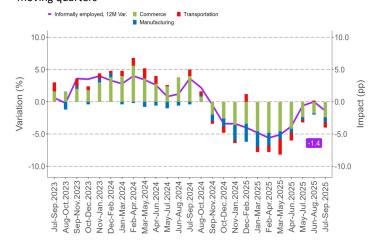
The highest informal employment rates were in households as employers (60.0%) and other service activities (49.8%).

### Analysis by occupational group<sup>3</sup>

The principal influences on the year-on-year decrease in informally employed persons (-1.4%) were the falls in service and sales workers (-4.3%) and administrative and support workers (-24.8%).

According to sex, the decrease in men (-2.3%) and women (-0.4%) was influenced by the fall in service and sales workers (-6.2% and -3.3%, respectively).

The highest rates of informal employment were in agricultural and fishery workers (57.4%) and craft and related trades workers (43.7%).

### Analysis by occupational category

According to occupational category, the variation in informally employed persons (-1.4%) was due to the falls in own-account workers (-5.1%), wage earners of the public sector (-8.1%), employers (-11.8%), and unpaid family workers (-8.4%). In contrast, increases in the informally employed were observed in wage earners of the private sector (5.7%) and domestic workers (2.2%).

The decreases in informally employed women (-0.4%) and men (-2.3%)

were influenced by the category own-account workers, which fell 3.7% and 6.2%, respectively.

The occupational categories own-account workers and wage earners of the private sector accounted for 86.6% of the total number of informally employed persons, and their informal employment rates were 64.6% and 15.6%, respectively.

By occupational category, the highest rates of informal employment were in own-account workers (64.6%) and domestic workers (55.9%).

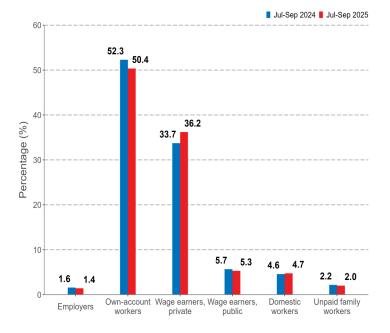

### Informal own-account workers

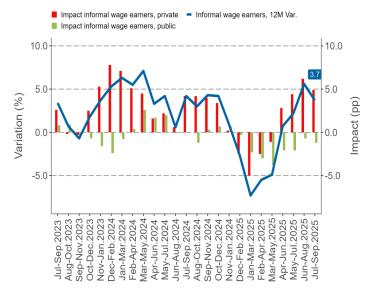
The year-on-year decrease in informal own-account workers (-5.1%) was influenced by the falls in men (-6.2%) and women (-3.7%). According to economic sector, the decrease can be attributed to the falls in commerce (-8.5%) and manufacturing (-9.1%).

### Informal wage earners

The twelve-month increase in informal wage earners (3.7%) can be exclusively attributed to the rise in wage earners of the private sector (5.7%) because the number of wage earners of the public sector decreased 8.1% during the same period. By economic sector, the increase in informal wage earners of the private sector can be attributed to the rises in accommodation and food service (11.9%) and education (19.9%)<sup>a</sup>.

For women, the informal employment rate outside the informal sector rose 0.5 pp year on year to stand at 13.5%. For men, this indicator rose 0.6 pp to stand at 9.7%.

In the same period, the employment rate in the informal sector decreased 1.2 pp year on year to stand at 15.0%.

### Analysis according to type of production unit

The informal employment rate outside the informal sector increased 0.5 pp year on year to stand at 11.3%. This indicator consists of the percentage of informally employed persons in formal economic units (the formal sector) and the percentage of informally employed persons in the sector households as employers. The former increased 0.5 pp to stand at 9.7%, and the latter showed no year-on-year variation, remaining at 1.6%.

### Hours usually worked

### Hours usually worked

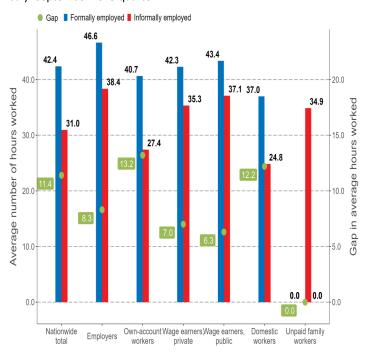
In relation to the number of hours usually worked, the decrease in informally employed persons was led by the falls in the brackets 45 hours (-33.3%) and 46 hours and over (-12.0%).

Of the informally employed persons who worked under 45 hours, 64.0% worked part time (between 1 and 30 hours per week). Of this group, 34.9% worked part time involuntarily and 63.3% worked part time voluntarily.

In regard to hours usually worked, formally employed persons worked an average of 11.4 hours more than informally employed persons. By occupational category, the greatest differences in average number of hours usually worked between formally and informally employed persons were in own-account workers (13.3 hours) and domestic workers (12.2 hours).
